# 2024 Membership Agreement

**Along with the rates and terms set forth in the Application for Membership to Colonial Hills Golf Club, I agree to the following general rules, regulations, policies, and benefits applicable to all memberships:**

1. I, the Member, agree to abide by all the rules, regulations and policies expressed by Colonial Hills Golf Club Inc. The Club reserves the right, on occasion and at any time, with or without notice, to change, modify, amend, or vacate its fees, rules and regulations and policies.
2. Golf members are entitled to play as many rounds of golf at the Club as the member desires, subject to the provisions of the Colonial Hills Golf Club Inc. rules, regulations, and policies. The Club will do its due diligence to make members' requests for tee times a priority. However, the golf member acknowledges that the golf course and practice facilities are open to the public and hosts daily fee golfers, tournaments, club-sponsored events, corporate outings, and charity events. Therefore, the golf course may not be available each time that a member chooses to play.
3. Golf members are allowed 10% off apparel in the Colonial Hills Pro Shop and the opportunity to purchase a cart discount card. If desired, members may also take advantage of a USGA/VSGA membership and obtain their handicap for a discounted rate.
4. The golf membership allows for participation in Club tournaments and special events. However, entry fees for special club events, as well as outside events, are not included in the golf membership dues.
5. Golf members and their guests agree to always check in at the golf shop before teeing off or using any of the practice facilities.
6. The golf membership will be effective from the date of the membership application acceptance and will remain in effect until the following December 31st, unless otherwise noted on this agreement.
7. Golf Member Agreements are legally binding for a period of twelve (12) months (January 1–December 31). If an individual joins mid-year, the membership will expire December 31 of that year. Early termination of a membership by a Golf Member requires payment of all prior charges. The Golf Member's account must be current at the time of cancellation.
8. Golf membership dues should be paid according to the payment options provided in the Club Application. Dues are non-refundable and non-transferable.
9. Golf memberships may be suspended or revoked for non-payment or for failure to abide by any of the rules, regulations, and policies of the Club. The membership may be recalled at any time at the discretion of the Colonial Hills Golf Club Management. In such a case, if annual dues were paid, they may be refunded on a prorated basis for the remaining months of the membership.
10. If a member's personal account is more than sixty (60) days past due, that membership may be suspended until the account is paid in full. It is the responsibility of the golf member to ensure that their current credit card information is on file with the Club. If paying by check, and the check is returned for insufficient funds, the member will be charged for all related bank fees. Any situation that arises due to insufficient funds or overdue accounts, may be handled on a case-by-case basis by the Colonial Hills Golf Club Management.
11. Colonial Hills Golf Club Inc. is not responsible for any loss or damage to any of the golf member's or guest's property that is used or stored at the club or brought onto the club property. The golf member should look solely to the golf member's personal insurance policies for any claim for loss or damage. The golf member and guest hereby release the Club from any and all causes of action, claims, and liability with respect to any loss or damage to any of the golf member's and guest's property that is used or stored at the Club or brought onto the property of the Club.
12. All damage to Club property, including golf carts, by golf members and guests, is the responsibility of the golfer and must be reported to the Pro Shop immediately.
13. In the event that a member has a concern or problem with a staff member or other issue, that concern should be addressed with the Club's Golf Professional or Owners of the Club.
14. This membership agreement supersedes any and all prior membership verbal or written agreement terms.
