Dear Colonial Hills Member,

With the 2025 season winding down and the new year fast approaching, we would like to wish you and your family a very happy holiday season!

Enclosed is the 2026 Membership Application which details next year's club membership rates. In keeping with Colonial Hills' history, we think you will find that the 2026 membership rates will continue to be competitive and the most affordable in the area.

Also enclosed is the Membership Agreement which details general rules, policies and benefits of membership. Though these forms are printed front and back on the same sheet of paper, please note that they are two separate documents, and both need to be reviewed carefully, filled out and signed. Here are a few highlights:

- Annual membership fees and the first monthly payment for January are due no later than January 31, 2026. A 3% discount for payments made by cash or check on fully paid annual memberships will once again be honored!
- Monthly payment options will require having a credit or debit card on file, and the first month is also due no later than January 31, 2026. Please check with your bank to ensure that this card is one that allows CNP (card-not-present) transactions so that so that monthly payments can be drafted without delay. Also, if your credit card information changes during the year, please be sure to let us know.
- If the annual or first monthly payment (whichever applies to you) is not made by January 31, 2026, the member's account will transition to a "public" account, making public green fees applicable on February 1, 2026 and membership benefits will no longer apply.
- Club Membership is a 12-month commitment, running from January 1 to December 31. If a member decides to rejoin later in 2026, the membership will not be prorated. Rather, the member will be required to make all monthly payments up to that date or pay the full annual membership.

When completing your application, please remember that your name is linked to your email address. To book tee times successfully, each member must have only one accurate email on file. If a member uses multiple emails, our system creates duplicate accounts, which leads to confusion both online and at the counter when reserving tee times. Once we receive your form, we will consolidate all accounts under the email provided on your 2026 membership application. We appreciate your cooperation. Let us know if you have questions about this.

We appreciate your support of the Tournament Program at Colonial Hills in 2025. Updates about what's coming to the course in 2026, as well as events and dates for the 2026 season will be shared in January. Thank you for making Colonial Hills your golfing home; we truly see every member as part of our extended family. If there's anything we can do to enhance your golfing experience, please let us know. Your continued support means so much to us, and we are sincerely grateful to have you as part of Colonial Hills Golf Club.

2026 Membership Agreement

Along with the rates and terms set forth in the Membership Application to Colonial Hills Golf Club, I agree to the following general rules, regulations, policies, and benefits applicable to all membership classes:

1. Members must agree to abide by all the rules, regulations and policies expressed by Colonial Hills Golf Club Inc. The Club reserves the right, on occasion and at any time, with or without notice, to change, modify, amend, or vacate its fees, rules and regulations and policies.

2. Members may make tee times up to seven (7) days ahead of time. They may play as many rounds of golf as they desire, subject to the provisions of the Colonial Hills Golf Club Inc. rules, regulations, and policies. The Club will do its best to make Members' requests for tee times a priority. However, the Member acknowledges that Club-sponsored events and tournament bookings take precedence over a Member's right to play golf.

3. Members are allowed 10% off apparel in the Pro Shop. They may also take advantage of a USGA/VSGA membership and obtain their handicap for a discounted rate. The membership also allows for participation in Club tournaments and special events. However, entry fees for special Club events, as well as outside events, are not included in the golf membership dues.

4. Cart fees are not included in the golf membership. However, a discounted 9-hole cart card and a discounted 18-hole cart card are available for purchase for Members only. Range balls are not included in the membership, but a Range Membership is available for Members to purchase.

5. The Member agrees that their likeness may be used in various Colonial Hills Golf Club communications including flyers, websites, social media accounts and video recordings.

6. The Member agrees to always check in at the Pro Shop before teeing off or using any of the practice facilities, even if they are just walking a couple of holes.

7. Club membership at Colonial Hills is a 12-month commitment, from January 1 to December 31. If a new individual joins mid-year, the membership will expire December 31 of that same year and the dues may be prorated. If an individual who was a member the previous year but did not renew the membership and then decides to rejoin later in the year, the membership will not be prorated. Rather, the Member will be required to make all monthly payments up to that date or pay the full annual membership.

8. If a certifiable medical condition occurs that prevents the utilization of your membership for a period of four (4) months or greater, you may request in writing a hold be placed on your account. Approval will be granted on a case-by-case basis.

9. Dues and memberships are non-transferable.

10. Golf membership fees should be paid according to the payment options provided in the Club Application. If the initial annual or first monthly payment is not made by January 31, 2025, the current Member's account will automatically transition to a "public" account, which means public green fees will become applicable and membership privileges will no longer apply on February 1, 2025. If a Member's personal account is past due, that membership may be suspended and/or playing privileges may be revoked until the account is paid in full.

11. Golf memberships may be suspended or revoked for failure to abide by any of the rules, regulations, and policies of the Club. The membership may be recalled at any time at the discretion of the Club Management. In such a case, if dues were paid, they may be refunded on a prorated basis for the remaining months of the membership.

12. It is the responsibility of the Member to ensure that their current credit/debit card information is on file with the Club for monthly payments. They must also ensure that the card is one that can be used for CNP (card-not-present) transactions. If paying by check for dues or for a golf shop purchase, and a check is returned for insufficient funds, the member will be charged for all related bank fees. Any situation that arises due to insufficient funds or overdue accounts may be handled on a case-by-case basis by the Club Management.

13. Colonial Hills Golf Club, Inc. is not responsible for any loss or damage to any of the Member's property that is used, stored at the Club or brought onto the property. The Member should look solely to the Member's personal insurance policies for any claim for loss or damage. The Member hereby releases the Club from any and all causes of action, claims, and liability with respect to any loss or damage to any of the Member's property that is used or stored at the Club or brought onto the property of the Club.

14. All damage to Club property, including golf carts, by golf Members and Guests, is the responsibility of the golfer and must be reported to the Pro Shop immediately.

15. This Membership Agreement supersedes all prior verbal or written membership agreement terms.
